## PART 1 SUMMARY OF RULES

- A. To impart constructive notice, an instrument must be "recorded as prescribed by law". *First Bank v. East West Bank* (2011) 199 Cal. App. 4th 1309, 1313 1315.*Hochstein v. Romero, supra* 219 Cal.App.3d 447, 452.; *Lewis v. Superior Court* (1994) 30 Cal.App.4th 1850, 1867.
- B. Indexing and the fiction: "there must at least be a way to find it". *Lewis*, supra, at 1867.
- C. Further detail: See LACBA Title Insurance Subsection Presentation of November 2019: "How Modern Technology Affects Whether Recorded Instruments Impart Constructive Notice"
  - 1. Note incomplete law on search methodology
  - 2. But access to (1) Index and (2) full image of each recorded document in the relevant portion of the index, and (3) all documents referred to therein, is necessary.
  - 3. Cal. Gov. Code § 27320:

"When any instrument, paper, or notice authorized by law to be recorded is deposited in the recorder's office for record, the recorder shall endorse upon it in the order in which it is deposited, *the year, month, day, hour, and minute of its reception*, and the amount of fees for recording. The recorder shall record it *without delay* ...."
